9. <u>Income Statements – End of December 2013</u>

The GM presented the "in-house" income statements for the end of December 2013. They were presented in detail at the Finance Committee meeting on February 18 and the results are in the minutes. The accountants will make some adjustments.

Motion No. 5

Upon motion duly made by Mr. Michel Leblond, seconded by Mr. Alpha Nadeau and unanimously carried, it was

MOVED To accept the "in-house" income statements for the end of December 2013 with a net profit of \$187,493.67 for all services, that is, governance, local planning, electrical generating station (biogas) and waste management services.

10. Correspondence report

Mr. Michel Leblond asked that the email received on March 13 from Mr. Cyrille Simard be discussed. Mr. Pierre Michaud said that he had had a call from Mr. Luc Michaud, who has the intention to acquire the Madawaska Airport and the Saint-Léonard Regional Airport from the City of Edmundston. Mr. Pierre Michaud confirmed that the RSC is playing the role of a facilitator.

Mr. Simard wanted to clarify certain points in his email: 1) He wondered whether the Finance Committee plays an executive role, because the committee had dealt with a subject that should not have been dealt with by the Finance Committee, and if such is the case the bylaws and regulations need to be changed. 2) Mr. Simard mentioned that the City of Edmundston is concluding an agreement, not yet finalized, with Aéroport du Madawaska Airport inc., a duly constituted body with a Board of Directors. 3) Since the agreement is not yet finalized, Mr. Simard finds it odd that there is a request to meet with the chairman of a non-profit organization when sitting at the table is the 'City of Edmundston,' which still owns both airports. He added that it would therefore be legitimate to think that Mr. Simard would be the best person at the table to address the matter. Mr. Simard described the current situation to reassure the municipalities in the region. The matter has been on the horizon for many years, and there have been all sorts of failed attempts, he said. The City of Edmundston wants to make sure that there is a form of air transport on a regular basis in the region to help economic development, and at the same time it wants to ensure that an infrastructure is available 24/7 for basic needs, such as the air ambulance, Canada Post, etc. The agreement stipulates that the assets cannot be sold and that the municipality will have a certain amount of control because one member of the Board of Directors of the organization will represent the City of Edmundston.

Mr. Allain Desjardins informed us that he had participated in the seminar: "Building with Design Sustainable Communities (or how to build healthier communities)". Mr. Desjardins found the concept very interesting for residential and commercial developers, etc. The concept takes into account the green plan, waterways, wetlands and trees while increasing the number of residences.

Mr. Desjardins also talked about the letter from the Rural Community of Saint-André (RCSA) to the RSC indicating that it was withdrawing its letter withdrawing from the RSC in February 2015. The RCSA municipal council decided to give the RSC a chance to prove itself and it will evaluate services each year to meet its partners' requirements. Mr. Desjardins said that RCSA already has

files with the RSC, that this trust has to be built up and that they need to continue to work together and cooperate.

Mr. Richard Keeley advised the members of the Board that the council of the Town of Grand Falls had met with the GM and the Chairman, Mr. Pierre Michaud. The Town of Grand Falls wants to give itself options and the decision to withdraw from the RSC is definitely not motivated by a lack of confidence in the RSC. It is purely a financial decision.

MOVED that RSC#1 authorize closing all accounts at the Caisse populaire du Madawaska Ltée for the planning section, account #3154, and inspection section, account #3330, and transfer the balances to RSC#1 North West's current account, #29434, to reimburse a total of \$21,519.85 to the LSDs. A total sum of \$57,775.15 will be divided and paid to the 7 municipalities based on their percentage of contribution, that is:

For the Village of Sainte-Anne, having unsightly premises services back under the RSC would be a very important factor in
