7. Opportunities New Brunswick – Ms. Élaine Albert, Community Economic Development Officer (Memorandum of Understanding between ONB and the NWRSC)

Further to the Memorandum of Understanding between ONB and the NWRSC, Ms. Élaine Albert is the Community Development Officer who was hired in January by ONB. She reports to Opportunities New Brunswick and is accountable to the NWRSC. Ms. Albert confirmed that she will be working closely with the executive directors of the municipalities and the mayors in the region on community projects. She informed the members about the Connect ONB Liens (www.onbconnects.ca) program and the Start-up Canada www.startupcan.ca program.

For the urban planning sector,

- That the NWRSC authorize a stop payment on cheque # 6602 to Bureau en Gros dated November 30, 2017, in the amount of \$81.41 because the supplier never received the cheque in question. The stop payment was approved by two signing officers, MM. Michel Leblond and François Picard, via Internet using Accès D. Cheque # 6602 was replaced by cheque # 6654 on December 22, 2017, to the same supplier for the same amount.
- That the NWRSC authorize the transfer to reimburse fees for building permits to the municipalities and LSD for the months of October to December 2017. Transfer of funds amounted to \$ 14,934.50 from account 29434 ES-2 to NWRSC current account, folio 29434. Variance between total repayments of \$ 21,068.50 and transfer of funds from the bank account of \$ 14,934.50 is due to the fact that several payments are received by credit card and / or debit which are deposited directly in the NWRSC current account. This transfer was approved on February 23, 2018 by two signing officers, including MM. Michel Leblond and François Picard via the Accès-D Internet of the Caisse populaire.

contacted Mr. André Daigle and Mr. Basile Chiasson, lawyers. The ED circulated an email from Mr. André Daigle indicating that they are ready to provide training to NWRSC members. The law firms are not receptive to the idea of establishing preferential rates for legal matters of the NWRSC member municipalities.

c) Presentation by Adrian Prado on adaptation to climate change: Mr. Prado is the NWRSC's environmental specialist, and he presented climate change adaptation initiatives in the region. There will be a public talk at the Madawaska Historical Museum this coming March 7.
