d) School Recycling Depots

Further to the Board resolution of last December 4, Marie-Eve suggested contacting Mr. Luc Caron, Executive Director of the Francophone North-West School District, to inform him that the recycling depots will be removed this summer and to discuss with him the various possible alternatives that the schools might adopt.
