He confirmed that the NWRSC may be able to bill the municipalities for COVID-19 expenses. Mr. Ouellet suggested that the NWRSC send the entire bill for COVID-19 expenses (amount to be determined) to his Rural Community and that the latter would send the application for reimbursement to the province. The NWRSC will bill each municipality for the amount of the credits received when recycling services shut down. This totals \$22,233.87.
