## 6. 2024 Budget for approval

The municipalities of Vallée-des Rivières, Grand Falls, Edmundston and Saint-Quentin have all approved the CSRNO budget in principle with the following conditions:

 That CSRNO establish a finance subcommittee made up of the EDs and/or finance directors of the local governments and CSRNO.

That the mandate of the subcommittee be as follows:

- Participate in preparing the budget for submission to the CSRNO Board
- Provide guarterly updates on CSRNO's finances
- Ensure that CSRNO's budget matches those of the municipalities
- That any investment exceeding \$50,000 be funded by loans through the NB Municipal Capital Borrowing Board in 2024.

Ms. Josée Levesque confirmed that the rural district also approved the budget with the same conditions.

The municipality of Edmundston added the following:

- That the other municipalities participating in the new public transit service confirm their financial participation in this important and essential initiative before this budget is adopted.

So, since the Town of Haut-Madawaska will adopt CSRNO's 2024 budget on Wednesday, November 8, official adoption of CSRNO's 2024 budget is delayed until an upcoming extraordinary meeting to be held this November 9 at noon via Teams.

MOVED THAT CSRNO go ahead anyway with Stantec, in partnership with Raymond Chabot Grant Thornton, for the study of the urban planning service in the area served by the Northwest Regional Service Commission, but that CSRNO ask that Mr. André Frenette be removed from the project because he has a conflict of interest in the matter.
